RESUME

Andrew Christie is the foundation Chair of Intellectual Property at Melbourne Law School, University of Melbourne. He has bachelor degrees in Science and in Law from the University of Melbourne, an LLM with distinction from the University of London, and a prize-winning PhD from the University of Cambridge.

An internationally-renowned teacher, researcher and practitioner of intellectual property law, Professor Christie has held distinguished appointments at Duke University, the National University of Singapore, the University of Cambridge, and the University of Toronto. He has authored more than 120 publications, and delivered by invitation more than 180 public addresses in 20 countries, across all areas of intellectual property law. His has been awarded 12 Australian Research Council research grants, and has been instrumental in winning other research funding in excess of \$11 million.

In addition to his academic work, Professor Christie is actively engaged in the practice of intellectual property law. He is admitted as a solicitor in Australia, England and Wales, and is a trained arbitrator and mediator. As an active panelist for leading dispute resolution centres in Geneva, Hong Kong, Paris and Sydney, he has decided more than 300 intellectual property-related disputes.

Professor Christie advises national governments and international organizations on intellectual property law and policy. He has served on all of the Australian Government's intellectual property advisory and reform committees, and has acted as an expert advisor to the World Intellectual Property Organization on a number of occasions. The leading international magazine *Managing Intellectual Property* has named him as one of the world's 50 most influential people in intellectual property.
